Item 1. Security and Issuer

Item 2. Identity and Background

- (a) Name of Persons Filing this Statement:
 - (1) Targa Resources Investments Inc. ("<u>Targa Investments</u>"), a corporation formed under the laws of the State of Delaware, owns 100% of the capital stock of Investments Sub (as defined herein).
 - (2) Targa Resources Investments Sub Inc. ("<u>Investments Sub</u>"), a corporation formed under the laws of the State of Delaware, owns 100% of the capital stock of Targa (as defined herein).
